RBMS GEARS UP FOR NEW ORLEANS

The RBMS Preconference in New Orleans this summer may not get the press coverage that the GOP convention on August 15 will, but it is promising a busy and informative four days at the beginning of July. It should also prove especially entertaining given the environment and the fact that RBMS will be celebrating its 30th anniversary at ALA. This "birthday" will be appropriately celebrated throughout the Preconference with such festivities as a birthday party and the honoring of RBMS's founders and past chairs.

The Preconference will be held July 5-8 and is entitled "Libraries and Museums: Leaves from Each Other's Books." The focus will be the relationship between special collections libraries and museums and what the two can learn from each other. To be discussed, from both theoretical and practical views, are such mutual interests as fund raising, public programs, access, cataloguing, collection development, and reference services. Speakers at the plenary sessions will include librarians, curators and scholars. A variety of seminars has been planned to encourage discussion of practical aspects of the Preconference theme and other topical issues. Among the seminar topics are conservation, exhibition catalogs, grant proposals for preservation and access, interlibrary loan of special collections material, collecting fine printing in both libraries and museums, museum artifacts and



art objects in special collections, risk management, and the history of science, medicine and technology.

Registration will be at the Preconference desk in the Omni Royal Orleans Hotel (in the French Quarter) on Tuesday July 5 from 2:00-5:00 p.m. and Wednesday July 6 from 8:30-9:15 a.m. Also on Tuesday there will be an RBMS Orientation Session from 4:00-5:00 p.m. (which new members are especially encouraged to attend) and an opening reception from 5:00-7:00 p.m. at the

Historic New Orleans Collection, 533 Royal Street, when RBMS's 30th anniversary will be celebrated. Additional receptions will be held at Tulane University and the Hermitage Plantation, a restored antebellum home. On Thursday, participants will be taken by bus to Louisiana State University in Baton Rouge for program events, tours and a luncheon at the Faculty Club.

All RBMS members should have received a more detailed announcement in the mail with registration information. Those who have not and would like to participate in the Preconference (you do not have to be a member to do so) should write ACRL/ALA, 50 E. Huron St., Chicago, IL 60611 (or call ALA at 800-545-2433). Once registered, applicants will receive further information on housing, dining, transportation and parking, and a map of the New Orleans area. RBMS PROGRAMS AT ALA

The fact that RBMS is sponsoring or co-sponsoring three programs at this year's Annual Conference is indicative of the ever increasing level of RBMS's interaction with other organizations within and beyond ALA. Please note that the dates and times listed below are tentative.

The RBMS Program, co-sponsored by GODORT and MAGERT, is entitled "Government Documents as Rare Books" and will be held on Sunday July 10 from 2:00-5:30 p.m. The program, chaired by Robert S. Martin, is a forum to discuss the problems of identifying rare government documents and to explore strategies for protecting and preserving these materials. Also during the program, printed citations will be presented to this year's Exhibition Catalog Award winners. James Green (Library Company of Philadelphia) is the Chair of the Program Planning Committee.

RBMS is also co-sponsoring a program titled "Insider Theft and Misappropriation." It will be in the form of a panel discussion; representatives from RBMS, the American Library Trustee Association (ALTA) and the Library Administration and Management Association (LAMA) will consider recent incidents of insider theft and their ethical and psychological dimensions, administrative contents, and the responses of the profession. It will be held on July 9, from 8:00-10:00 p.m.

The ACRL Legislation Committee Program at Annual Conference is entitled "Information Access: Issues and Action." RBMS is co-sponsoring this program with GODORT and the Coalition on Government Information. William Keller, Chair of RBMS's Legislative Information Committee, will speak on tax and legislative issues having impact on the public's access to research resources. This program will be on July 10, from 2:00-4:00 p.m.

NEW RBMS COMMITTEES

Five new RBMS committees were instituted by Executive Committee motions during Midwinter.

On the Legislative Information Committee's suggestion, an Ad-hoc Committee on Gifts and Appraisals was established to prepare an informational brochure on gifts and appraisals for distribution by institutions

to potential donors and for internal use. Stephen Ferguson (Princeton) will chair that committee.

An Ad-hoc Ethical Standards Review Committee was formed to review the ethics guidelines produced by an earlier RBMS Ethics Committee in view of the recent occurrences of insider theft; Terry Belanger (Columbia) will chair.

An Ad-hoc Committee on RBMS Records' Retention has been created for a two year period to examine the problems of records retention within the Section and to develop appropriate guidelines for the establishment of a records' retention policy.

An Ad-hoc Committee on Statistics has been formed to investigate the feasibility of undertaking a statistical survey of rare book and manuscript libraries.

An Ad-hoc Committee to Revise the Guidelines on Archives and Manuscripts has been created to work solely on the completion of those very necessary and extensive revisions.

COMMITTEE ACTIVITIES

The Legislative Information Committee (Chair: William Keller, George Washington University) is in the process of reviewing its recent survey of institutions regarding the consequences of the 1984 tax reform act with the intent of publishing a summary in C&RL News. The Continuing Education Committee (Chair: Barbara Paulson, Columbia), besides working busily on the seminars for the Preconference, recommended to the Executive Committee in January that its name be changed to the Education and Professional Development Committee and a sub-committee has been established to review its goals. In January, the Orientation Manual Committee (Chair: Donald Farren, University of Maryland) decided that such a manual would ideally be geared towards newly active RBMS members, basing it upon the orientation materials distributed at the 1987 Stanford Preconference. The Nominating Committee (Chair: Donald Farren) will be announcing a full slate of candidates for the 1989 elections in New Orleans. The Publications Committee (Chair: James Green, Library Company of Philadelphia) has been charged by the Executive Committee to continue to work toward publishing a membership directory as a membership service, and to investigate ACRL policies on the use of royalties and profits derived from section publications. In January, the Standards Committee's

(Chair: John B. Thomas, Humanities Research Center) revisions of the Guidelines on Manuscripts and Archives stalled and a new committee has been created to work on these revisions. After the Standards Committee's unanimous approval of the guidelines produced by the Security Committee (Chair: William Moffett, Oberlin), those Guidelines on Theft were approved by the ACRL Board. The Borrowing Special Collections for Exhibition Committee (Chair: Ellen Dunlap, Rosenbach Museum) has referred its draft guidelines to the Standards Committee, which will be reviewing them in July. The Curator/Conservators' Collations Committee (Chair: Terry Belanger, Columbia) has a final draft of its guidelines ready to pass before the Standards Committee; the committee will probably be dismissed, having fulfilled its intentions, at Annual Conference in New Orleans. The Literary Rights Committee (Chair: Cathy Henderson, HRC) is continuing to solicit comments on its draft informational pamphlet, "Copyright Strategies for Unpublished Literary Manuscripts." Anyone who would like to read and comment is urged to request a copy from Cathy; the committee wants to complete a final draft at its July meeting. The committee has also been approached by a commercial publisher interested in publishing a directory of the names and addresses of holders of literary rights in unpublished manuscripts. The Curators and Conservators Discussion Group (Chair: Cathy Henderson) reviewed the work of the Curator/Conservators' Collations Committee in January; it is also currently discussing the relative merits of in-house vs. contracted conservation treatment. The Manuscripts and Other Formats Discussion Group (Chair: Bob Blesse, University of Nevada/Reno) in January discussed the legal actions being taken by the estate of Martin Luther King against Boston University. The MARC for Special Collections Discussion Group (Chair: John Thomas) held its first Midwinter meeting in January. The RBMS/GODO-RT/MAGERT Joint Committee (Chair: Nora Quinlan, University of Colorado/Boulder) is busy exploring a variety of co-operative activities.

LIAISONS

Based upon the past success of repeated ALA and SAA program sessions at each other's respective conferences, the ALA/SAA Joint Committee (Liaison: Joan Friedman, Yale Center for British Art) decided that this practice should continue and that the following programs be shared: Buildings and

Equipment for Archives and Special Collections (SAA Program Session) and Collecting Local History (ALA/RBMS 1989 Program Session). The committee is also interested in promulgating joint standards and guidelines and will be joining in the revision of the Guidelines on Manuscripts and Archives for which a new RBMS committee has been formed. The RBMS Orientation Open House at SAA's Annual Conference last fall was very well received and plans are underway to hold another at SAA in Atlanta, which Robert Blesse will be organizing.

Charlotte Brown (Franklin and Marshall College), liaison to RTSD's Preservation of Library Materials Section, announced in January that PLMS has bibliographies in progress on paper standards and preservation; PLMS is also interested in sponsoring a grant writing program and in developing guidelines for teaching preservation and is eager for RBMS input.

Sally Leach (Humanities Research Center) has been appointed to the ACRL Task Force Committee on Awards, Ad-hoc. The committee's charge is to review the various ACRL awards and to produce a manual of uniform policies and procedures.

CAMBRIDGE (ENGLAND) IN 1989

Sept. 5-8, 1989, RBMS will sponsor a major conference in Cambridge, England on the international antiquarian book trade with particular emphasis on the flow of material across the Atlantic. The conference will include sessions on historical as well as contemporary issues, and it should provide members with a thorough introduction to the international trade in rare books and manuscripts. Speakers will be drawn from universities, libraries, and the trade, and the conference will allow members to hear and meet distinguished colleagues from abroad whom they might not otherwise have occasion or opportunity to encounter. The planning committee believes that the conference will be of substantial interest and practical value to all RBMS members whose work necessarily involves a knowledge of the book trade, past and present. We expect to be joined in the conference by our colleagues from the Library Association, so that the Cambridge meetings will also give members a chance to meet some of their British counterparts.

Blocks of rooms have been reserved for us at Newnham College, and per diem costs for members should be low enough to make the conference additionally attractive. Moreover, arrangements have been made with Newnham College to allow those who wish to stay on in Cambridge after the conference a chance to do so at bargain rates.

Members of the Planning Committee include James Green, William Joyce, Marie Korey, Richard Landon, Bernard Rosenthal, and Michael Ryan (Chair). David McKittrick, Librarian of Trinity College, has kindly agreed to handle local arrangements on our behalf. Questions or suggestions concerning the conference should be directed to William Joyce (Princeton) or Michael Ryan (Stanford).

1989 PRECONFERENCE

One by-product of the Cambridge conference will be an abbreviated RBMS Preconference prior to ALA's 1989 Annual Conference in Dallas. That Preconference will take place June 22-23 at Southern Methodist University. The 1989 Dallas Preconference Committee (Chair: Sid Huttner, University of Tulsa) announced that its theme will be local history, its collection, development and care. The 1989 Dallas Program Planning Committee (Chair: Pat Bozeman, University of Houston) has decided to also treat local history ("Collecting Local History and Promoting its Use") as its theme.

ESTC/NA

The last Newsletter's article on ESTC left the mistaken impression that ESTC/NA processed all of the records of the Oxford and Cambridge libraries. In fact, the North American team processed only the records of the college libraries; the records of the Bodleian Library at Oxford and the University Library at Cambridge have, of course, been processed by the team at the British Library.

AMERICAN PRINTING HISTORY ASSOCIATION

At APHA's annual meeting in January the awards for distinguished contributions to the field of printing history were presented. The individual award went to Edwin Wolf, 2nd, Librarian Emeritus of the Library Company of Philadelphia, and the institutional award went to the Kemble Collections of Printing and Publishing at the California Historical Society.

For the first time in its 13 year history, APHA's September annual conference will be held outside of New York City. It will be in Philadelphia and the title is "The Book Arts in Philadelphia, 1785-1840." The conference will coincide with "Legacies of Genius", a city-wide exhibition of 250 of the most significant rare books and manuscripts from 16 area libraries' collections.

IFLA

The Rare and Precious Books and Documents Section of the International Federation of Library Associations and Institutions (IFLA) provides a forum for an international group of librarians concerned with the collection and preservation of rare books and manuscripts. It also feels a special responsibility for the cultural interests of

IFLA at international, regional and national levels and works to relate directly with other relevant sections of IFLA. These basic intentions are approached through the Section's programs at an Annual Conference and the continuing discussion of three specific issues: the history of the book and libraries, retrospective bibliographical control, and exhibitions for the general public. Currently, three projects reflect these interests: 1. The Annual Bibliography of the History of the Book and Libraries (ABHB). 2. Gesamtkatalog der Wiegendrucke (GW). 3. World Directory of Museums of the Book. The Section's Program at this year's Annual Conference in Sydney (apart from business) will focus on Australian/New Zealand collections and their relationship to European/North American traditions of collecting.
